

RELEASE, WAIVER AND INDEMNITY AGREEMENT

On behalf of myself, and any of my minor children who may attend dog obedience class with me, as part of the consideration for Aylwyn, LLC accepting my application for admission to the dog training classes, I acknowledge and agree as follows:

1. I understand that both attendance and participation at a dog obedience class is not without risk. I also acknowledge that if I participate, or allow any of my minor children to attend or participate, I choose to do so voluntarily, knowing that this activity has some risk and danger. I understand that Aylwyn, LLC does not provide supervision of dogs, minors or adults at or during the dog obedience classes or upon the facility where the classes are given, and it is therefore impossible to guarantee the safety of any person or dog before, during or after the class. Therefore, I understand that when I am waiting for the class to begin, during the class and after the class I assume all risk and legal responsibility for injury to me, my dog and/or any of my minor children who may be with me.

2. I fully understand that this agreement covers, all known and unknown risks, dangers and conditions that are an integral part of dog-related activity, including but not limited to, any of the following: (a) the propensity of a dog to unexpectedly behave in ways that may result in injury to people or other animals; (b) the unpredictability of a dog's reaction to such things as sound, sudden movement, unfamiliar objects, persons, or other animals; and, (c) the potential of a person to act in a careless or negligent manner that may contribute to injury to themselves and/or any other person(s), including but not limited to, failing to maintain control over a dog or failing to act reasonably under the circumstances.

With full knowledge of the foregoing, I agree not to sue Aylwyn, LLC, and I release and agree to indemnify Aylwyn, LLC, its employees, members, landlords and agents from and for all liability for loss or damage, and any claims or demands on account of injury to the person or property or death whether caused by the negligence of Aylwyn, LLC or otherwise. *I understand and agree that this release, waiver and indemnity agreement is intended to be as broad and inclusive as is permitted by the laws of the state of Illinois*, and if any part hereof is held invalid, it is agreed that the balance shall continue in full force and effect. I have executed this agreement freely and voluntarily and for and on behalf of myself and/or my child and for anyone claiming under or through any of them, and for each of their respective heirs, administrators, successors, representatives and assigns.

BEFORE SIGNING THIS AGREEMENT, I ACKNOWLEDGE THAT I HAVE READ AND FULLY UNDERSTAND ALL OF THE INFORMATION IN IT. I ACKNOWLEDGE THAT I DO NOT NEED ANY FURTHER EXPLANATION OF ITS CONTENTS AND WAIVE ANY FURTHER EXPLANATION. I HAVE VOLUNTARILY AGREED TO ITS TERMS AND PROVISIONS AND I AGREE THAT NO OTHER STATEMENT, REPRESENTATIONS OR INDUCEMENT APART FROM WHAT IS STATED IN THIS AGREEMENT HAVE BEEN MADE TO ME TO OBTAIN MY CONSENT AND MY SIGNATURE TO IT.
